## **Minutes of the Annual Parish Council meeting held immediately after the Annual Parish Meeting**

**Pointon Village Hall, Thursday 31 May 2018**

### **1. Election of Chairman and Declaration of Acceptance of Office**

The Clerk asked for nominations. Cllr Lambert proposed Cllr Greenwood, this was seconded by Cllr Sharples. As there were no other members Cllr Greenwood was elected Chairman, and accepted office. No declaration required as still holding name position.

The Chairman resumed his position on the Council

### **2. Election of Vice-Chairman and Declaration of Acceptance of Office**

3.2 After presentations by the remaining applicants, a vote was taken and Mr A Scarfe, Mrs C Green, Mrs W Moore and Mrs J Keeley were duly co-opted members of the Council
